### The Value of the Silver Economy using the Gold of the Future

EKTG is again pleased to be running a session at the **AAL Forum in Denmark 23-25 September 2019**.

Data is widely recognised as the 'New Golden Resource' of the 21st Century offering both business and society the prospects of responsive and coordinated services. Cost effective and timely data can and should be used to protect and improve the health and independence of older people, their families and carers.

EKTG was established by DG CONNECT at the AAL Forum in Denmark in 2010. Since then data science has developed in sophistication, such that current systems can suggest appropriate actions to decision makers. However, the complexity of care and variety of stakeholders involved has resulted in the main in suboptimal outcomes. Barriers to usage are caused by lack of relevant data, poor interpretation of existing data, and reluctance to share data. This may be exacerbated by ethical and privacy issues surrounding data science. Users rarely feel they own their own personal data, with anxieties about misuse by other people.

This 90 minute session will offer good practical examples of how data usage can benefit society, assisting in a healthier, happier populations. We will also demonstrate lessons learned so providers can better tailor their data science-based services in future. Session discussions will encourage confidence in such services by participants.

### **New CEO for NHSX**

The Government recently announced that the Head of Government digital policy chief, Matthew Gould, will be the new CEO of NHSX, whose mission statement is to make sure patients and staff have the digital technology they need by overseeing the digital transformation of the health and care system. NHSX is designed to bring together the Department of Health and Social Care, NHS England and NHS Improvement. ## Obituary: Sir David Rowlands

At the very first EKTG Meeting which we held in the UK in 2010 at the London School of Economics, we were fortunate enough to have some strong contributions made by Sir David Rowlands, the then Chairman of NatWest Bank.

Sir David joined the group of specially invited guests which made up the first EKTG meeting. This was run in collaboration with DC CONNECT in Brussels and the then Department of Trade in Whitehall, now Department for Business, Energy and Industrial Strategy (BEIS).

Amongst other things David shared with us some of his thoughts during the first week when he took up office as Chairman of Nat West Bank. One of his first questions was if there had been any recent complaining letters to the Chairman and if so he wanted to see them. His new PA assured him that the Bank had a whole section to deal with that type of thing and he should not worry that any questions of that nature would all be dealt with properly on his behalf. David asked to see a dozen or so representative letter straight away. On after this he insisted that he should see a specific representative set of correspondence each week! This he understood was a new system for any Chairman to follow.

David was an amazing man who contributed so much and yet regularly understated his own abilities. He claimed his success was down to the fact that I always employed people more intelligent than himself, pinch their ideas, but always remember to say thank you. Maybe more of us could apply his philosophy and we would all gain.

We thank David Rowlands for sharing some of his experiences with EKTG at our first UK Meeting in 2010.
