The UK Referendum outcome. What does this mean for us all?

The EKTG Leadership Group has discussed the implications for the EKTG of the result of the UK Referendum on remaining or leaving the EU, held on 23rd June. EKTG is a group which encourages European eHealth and Assistive Technology collaboration, not only in Europe but also between Europe and other parts of the World. Consequently, the implications of the result are important.

The UK will remain in the EU until the process of leaving is completed. This will take a number of years and it is, therefore, sensible to keep our options open until more detail is known

In the meantime, we plan to continue to work closely with colleagues throughout the EU and beyond. Cross-border and cross-cultural scientific research and development is essential for the benefit of European citizens as populations age.

How to deliver better healthcare across Europe: seven 'Vital Signs' of a healthy health economy

Health systems in Europe are diverse, the result of history, culture and the economic and political environment in which they operate. They range from predominantly single-payer systems, such as the UK and Spain, which tend to spend a lower amount of their resources on healthcare; to systems of competing insurers and providers such as Germany and the Netherlands, which are two of Europe's highest spenders on healthcare. Understanding what makes an effective healthcare system is quite challenging.

The Deloitte Centre for Health Solutions' recent report, Vital Signs- How to deliver better healthcare across Europe, explores the performance of six European countries - Denmark, France, Germany, Netherlands, Spain and the UK, to try and understand how they tackle common health and care challenges.
