## The United Nations needs science advice now more than ever

The UN's Scientific Advisory Board has done pioneering work. If it is not renewed, policy will suffer, say Susan Avery and Maria Ivanova.

"Science makes policy out of brick, not straw," the <u>Scientific Advisory Board</u> to the United Nations secretary-general wrote in its <u>summary report</u> in September 2016. Twenty-six of us, scientists from a range of disciplines and countries, had worked for more than two years to provide advice on science, technology and innovation for sustainable development to the UN secretary-general. ## **Direct Payments in Residential Care**

Direct payments have been extended to people living in residential care in England for the first time, in a pilot programme initiated by the UK Department of Health (DH).

The payments are one method of delivering personalisation, an approach towards public services where support is tailored to the needs and preferences of individual people, in order to promote independence through greater choice and control. Read more here.

## Public Consultation to evaluate Public-Public Partnerships such as the Active and Assisted Living funding programme

The Active and Assisted Living Joint Programme (AAL JP) was launched for the period from 2014 to 2020. Together with its predecessor Ambient and Assisted Living Joint Programme (2008 − 2013), it has been investing about €650 Million in ICT projects with an ageing dimension. This consultation aims to collect views of the public about the implementation of Public-Public Partnerships under the Horizon 2020 funding programme. Read more...

## **Green Paper on Social Care Funding**

In his Budget on 8 March, The UK Chancellor announced a Green Paper on social care funding. This is expected round about the Autumn Budget.

Ron Wheatcroft, technical manager at Swiss Re said: "While the Government

income, funding has been insufficient to plug the long term care gap for far too long. The government, industry and society as a whole have a responsibility to develop a sustainable solution which establishes the right balance between state and private provision and which does not penalise self-provision.

"The Green Paper needs to take a rigorous approach to create a sustainable solution where the responsibilities of all are clear but cannot create further delay. For most people, there will be no single product which meets all their needs and we see a role for using savings alongside insurance and equity in property. Alongside this, the Government needs to press ahead with clear messages clarifying responsibilities and growing awareness."

MAFEIP ('Monitoring and Assessment Framework for the European Innovation Partnership on Active and Healthy Ageing') was initially developed in response to the specific monitoring needs of the EU Innovation Partnership. ## **UK Digital Strategy 2017**

The Government has released its <u>Digital Strategy</u>, designed to complement its Industrial Strategy. The strategy is made up of seven pillars, and includes a commitment to implement a Universal Service Obligation, giving every individual, business and public premise across the country the right to request an affordable high speed broadband connection, as well as a commitment to invest over £1 billion to accelerate the development and uptake of next generation digital infrastructure - including full fibre and 5G.
