Carers Action Plan (UK)

on 5 June the Carers Action Plan was launched by the Care Minister, Caroline Dinenage. During the subsequent Carers Week 2018 the theme was 'Healthy and Connected' and at the launch the important role that technology could play in enhancing the life experiences of both carers and the cared for was highlighted.

Within Chapter 4 of the Carers Action Plan, 'Recognising and supporting carers in the wider community and society', on P. 25, is a section entitled Technology and innovation, which includes actions which seek to improve carers' everyday experiences, raise societal awareness of carers and help create carer friendly communities by using innovative ideas supported by technology.
