Implementation of AAL-Services & Support / Education

Necessary basic conditions:

- General support and monitoring of the end-users of AAL-services: provide access to innovative technologies and services based on sound knowledge of social life styles, geriatrics and family discussions, empowerment, activation in iterative processes

- Education of professional staff in the use of applied AAL-solutions in the private living and e-Health-sector: provide confidence, acceptance and knowledge

- Digitalization and patient empowerment result in new requirements and challenges. In response, the module "Clinical Telemedicine/e-Health" was implemented by the Faculty of Medicine of Zurich in 2008. The module was systematically evaluated to determine if the students would benefit from this course. In 2011, 2015, and 2016 further evaluations were performed.

- Every mean value of the combined evaluations of 2008/2009, 2011, and 2016 achieved a score of over 4 on a 6-point scale. In 2011, and also again in 2016, the overall satisfaction and understanding of telemedicine as a supplement in traditional medical consultations increased as follows: 4.71 ± 0.74 versus 4.86 ± 0.93 versus 5.1 ± 1.5 and, respectively, 5.02 ± 0.96 versus 5.25 ± 0.81 versus 5.7 ± 0.6 .
